





# Integration into Hazard Mitigation Plans



**FEMA**



- Five of the six counties in the TBRPC service area have Local Mitigation Strategies that will expire in 2020.
- Although FEMA encourages the inclusion of climate change/sea level rise, it is not required for local government plans.
- State level hazard mitigation plans are required to include consideration of changing future climate conditions based on 2016 guidance from the Federal Emergency Management Agency (FEMA).
- The 2018 SHMP includes a summary for each natural hazard identified, and an explanation of how each hazard might be exacerbated by climate change.
- Pinellas and Citrus counties will follow the SHMP model, while Manatee County will assess climate change as a separate hazard.



# Integration into Transportation Plans



- Pinellas, Pasco and Hillsborough MPOs are currently conducting their 2045 Transportation Plan (LRTP) Update.
- New federal requirements state that Long Range future LRTP updates must work on “improving the resiliency and reliability of the transportation system and reducing or mitigating the stormwater impacts of surface transportation ...”
- This initiative is one of 11 Federal Highway Administration Resilience and Durability to Extreme Weather Pilot Program projects to improve transportation infrastructure
