Dr. Barnali Dixon, Initiative on Coastal Adaptation and Resilience (iCAR), University of South Florida St. Petersburg campus


- Reviewed maps and data collected from the community.

 Reviewed the Pinellas and Hillsborough United in Recovery Long Term Recovery Group (LTRG), a Recover Pinellas initiative that unites VOADs, nonprofits, and community partners to deliver disaster recovery assistance, such as home repairs, furnishings, and financial aid, to low- to moderate-income residents and organizations, with case management support from Endeavors and SALT.
